## Coronavirus (COVID-19) Cases in Licensed Child Care Facilities in California Week of 08/25/2021

The California Child Care Licensing Program collects COVID-19 positive cases for licensed child care facilities statewide. The figures and tables in this report represent COVID-19 positive cases at child care facilities licensed by the California Department of Social Services, Community Care Licensing Division. Data are presented for those counties with at least three open child care licensed facilities for any given type (e.g., Child Care Centers, Large Family Child Care Homes<sup>1</sup>, Small Family Child Care Homes<sup>2</sup>), in consideration of privacy and security concerns. This report also includes tables for the total number of open licensed facilities for Child Care Centers and Family Child Care Homes statewide in each of California's 58 counties. The number of open facilities accounts for temporarily closed facilities due to COVID as well as permanently closed facilities. Open facility counts in this report will differ from facility counts on the transparency website which reflect only permanently closed facilities.

The figure and tables in this report identify the counties with eleven (11) or more COVID-19 positive cases and at least three open child care facilities, unless otherwise stated. Values of less than eleven (11) are masked (shown as <11) and values of eleven (11) or more that could be used to identify masked values are also masked (shown as \*\*) in accordance with de-identification guidelines. True values of zero appear as "0". If a county does not have at least three open facilities of a given type, the county data for that facility type is removed and appears as "N/A". The figures and tables below represent the cumulative values for a given time period.

## Types of Licensed Child Care Facilities in California

<u>Licensed Child Care Centers</u>: A Licensed Child Care Center (or Day Care Center) is usually located in a commercial building. Non-medical care and supervision are provided for infant to school age children in a group setting for periods of less than 24 hours.

<u>Licensed Family Child Care Homes</u>: A Licensed Family Child Care Home must be in the licensee's own home. A Family Child Care Home reflects a home-like environment where non-medical care and supervision are provided for periods of less than 24 hours.

- Small Family Child Care Homes provide care to no more than 8 children.
- Large Family Child Care Homes provide care to no more than 14 children.

Effective October 2, 2020, a methodology adjustment to our data tracking system was made in how positive COVID-19 cases are counted. This resulted in an increase in the overall total of cumulative cases since mid-April, 2020.



Figure 1. California's Licensed Child Care Facilities Total COVID-19 Cases by County\*\* as of 08/25/2021




Figure 2. Weekly 7-Day average positive COVID-19 active\* cases in California's licensed child care facilities among staff, children, parents and other over the past month (Data Retrieved: 08/25/2021)
